Undergraduate English Benchmark Policy for Graduation

- 1. To enhance students' English learning objectives, the Language Education Center has imposed an English graduation benchmark on the students of CJCU.
- 2. Undergraduate students who fail to meet the requirements of the English benchmark two years prior to graduation, they are required to take an English supplementary remedial course, and they need to pass it in order to graduate.
- 3. English supplementary remedial course takes a total of 36 hours to complete, and it is zero credit.
- 4. Those who intend to take the English supplementary remedial course must first register to the course and pay for the fees before the announced registration deadline. Students must also hold a valid proof of any English proficiency test taken previously. Please refer to the list of English proficiency tests shown below.
- 5. Students are required to pass one of the standardized English proficiency tests prior to graduation, with a score that meets the requirements described in the following tables.
