- 第1條 為使本學程學生強化所學領域之實作與應用能力,以利學生於畢業時快速投入環境 及社會之永續發展相關工作,依據本校「學生專業實作能力檢核實施辦法」第二條 規定,訂定本學程之「學生專業實作能力檢核實施規定」(以下簡稱本規定)。
- Article 1 To enhance the practical and applied skills of students in this program, enabling them to quickly engage in work related to sustainable development in the environment and society upon graduation, these "IPSD Student Competencies Assessment Regulations" (hereinafter referred to as "the Regulations") have been established in accordance with Article 2 of the university's "Implementation Measures for Assessing Students' Professional Practical Competencies."
- 第 2 條自 106 學年度起入學之學程學生,需於畢業前修畢至少一組實務課程模組,以作為本學程學生之畢業之門檻。此條文自 112 學年度起入學之新生不適用。
- Article 2 Commencing with the 2017 academic year, IPSD students are required to complete at least one set of practical course modules before graduation. This provision does not apply to IPSD students enrolling from the 2023 academic year onward.
- 第3條 本學程自 112 學年度起入學學生,需於畢業前完成或通過下列至少一項專業實作項目,以符合本系畢業之門檻。(一)實習:修畢本學程「根與芽行動實習 I」課程,並以個人或團體形式公開發表實習成果。 (二)實作研討:修畢本學程「專題實作」課程或進行專題/專案/個案之實作研討,並以個人或團體形式公開發表實作研討成果。 (三)競賽:以個人或團體形式參與永續發展專業區域性/全國性/國際性競賽,並公開發表成果。(四)研發:完成國科會大專生研究計畫一件。 (五)其他未列項目可提學程會議審議。
- Article 3 Beginning with students enrolled in the 2023 academic year, IPSD students must complete or pass at least one of the following professional practice requirements before graduation to meet the program's graduation criteria:
 - 1. Internship: Successfully complete the "Roots and Shoots Internship I" course and publicly present the internship results as an individual or group.
 - 2. Practical Workshop: Successfully complete the "Special Topic" course or conduct a practical workshop on a project/case and publicly present the results as an individual or group.

- 3. Competitions: Participate as an individual or group in regional, national, or international competitions related to sustainable development and publicly present the outcomes.
- 4. Research and Development: Complete one research project under the National Science and Technology Council's University Student Research Program.
- 5. Other activities not listed may be submitted for review by the IPSD Academic Affairs committee.
