- 5. Personal Information Processing and Utilization

If you are under twenty years of age, your legal representative should read and understand the notification statement. However, if you have accepted the service, you will be deemed to have obtained the consent of the legal representative.
- 9. In the event that CJCU needs to use your personal information other than the purpose of the collection on this notice. Unless superseded by other laws, CJCU will obtain your written consent in accordance with regulations.

If CJCU violates the provisions of the "Personal Information Protection Act" or due to natural disasters, incidents or other force majeure may be stolen, leaked, tampered with, or otherwise infringed. If this is identified, CJCU will notify you in a proper way in accordance with the relevant provisions of the "Personal Information Protection Act Implementation Rules."
