5. Personal Information Processing and Utilization
  - A. When: The duration of the specified purpose for which the personal information was collected, the length of the period of preservation according to the preservation of the relevant laws and regulations, or the period of preservation required by the school for the execution of teaching and administrative related business.
  - B. Where: Domestic and foreign business establishments that have business dealings with us.
  - C. Who: Our teaching and administrative related business personnel, agencies that have the right to investigate according to the law, and the competent administrative agencies.
  - D. How: Take advantage of honesty and credit methods in automated machines or other non-automated ways.
6. According to Article 3 of the Law, you are entitled to exercise the following rights in relation to your personal information in accordance with the provisions of the Funding Law, and you must not abandon in advance or use special restrictions:
  - A. You may have an inquiry, request for reading or request for copying from this school. However, the school may a fee as required by law.
  - B. You may ask us for supplements or corrections, but you should interpret it as appropriate.
  - C. You may request the school to stop collecting, processing, or using and requesting deletion. However, if CJCUC is required by law to perform this business, it may not comply with the request.
7. You are free to choose whether or not to provide relevant personal data. However, if you refuse to provide relevant personal information, CJCUC will not be able to carry out the necessary audit and processing operations, and be unable to process your application.
8. You understand that this statement complies with the requirements of the Personal Information Protection Act and related regulations. If you are under 18 years of age, your legal representative should read and understand the notification statement.
9. CJCUC will reserve the right to modify the specifications of this consent form at any time. When we change its specifications, it will announce the facts on the website, or notify in an appropriate manner. If you do not agree with the revised content, do not continue to accept this service. Otherwise, you will be deemed to have consented to and accepted the restrictions of the addition or amendment of this consent form.
10. In the event that CJCUC needs to use your personal information other than the purpose of the collection on this notice. Unless superseded by other laws, CJCUC will obtain your written consent in accordance with regulations.
11. Your personal information is protected and regulated by the "Privacy Policy statement" of CJCUC. If CJCUC violates the provisions of the "Personal Information Protection Act" or due to natural disasters, incidents or other force majeure may be stolen, leaked, tampered with, or otherwise infringed. If this is identified, CJCUC will notify you in a proper way in accordance with the relevant provisions of the "Personal Information Protection Act Implementation Rules."

12. If there is any question with this statement, it shall be handled in accordance with the provisions of the Personal Information Protection Act and other relevant regulations.
